Prof. David A. Callies, FAICP, ACREL, Kudo Professor of Law, Program Co-Chair, of the William S. Richardson School of Law, University of Hawaii, came to the School in 1978, following a decade of adjunct teaching and private practice where he counseled local, state, and national government agencies in land use management and control, transportation policy, and intergovernmental relations.

David M. Forman joined the William S. Richardson School of Law, University of Hawaii, in 2010 as Assistant Faculty Specialist for the Environmental Law Program, Health Law Policy Center and Ka Huli Ao Center for Excellence in Native Hawaiian Law.

Patricia E. Salkin is the Associate Dean, Professor of Law and Director of the Governmental Law Center of Albany Law School; Albany, NY. She teaches courses in Land Use Law, Housing Law and Policy, New York State Admin Law, Current Legal Issues in Government, and Government Ethics.

Joshua B. Y. Strickler is the Facilitator of Renewable Energy Programs with the Hawaii Department of Business, Economic Development and Tourism. He works with agencies at the Federal, State, and County level on the permitting and approval of renewable energy projects in the State of Hawai`i.
